

DOG WALKING/PET SITTING WAIVER FORM

I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending walks, pet sitting or any activities with Strutting Mutts Dog Walking & Pet Services.

I also understand and agree that in releasing my dog(s) in Strutting Mutts care, Strutting Mutts has relied upon my representation that my dog(s) is/are in good health and have not harmed or shown aggressive or threatening behaviour towards any person or any other dog.

I further understand that due to the way that dogs interact with one another, minor cuts and scratches can occur even though the dogs are carefully supervised at all times.

While my dog(s) is/are in the care and custody of Strutting Mutts, if I am unreachable in the event of an emergency, I hereby authorize Strutting Mutts, its staff, and/or representatives to seek immediate veterinary care for my dog. I understand that all costs in connection with, veterinary, medical or other treatment shall be my responsibility.

I hereby release and agree to save and hold harmless, Strutting Mutts, it's directors, officers, shareholders, employees, assistants, members and agents from any and all liability, claims, suits, actions, loss, injury or damage of any nature or kind, or for any liability, claims, suits, actions, loss, injury or damage which I or my dog(s) may sustain or which may be caused in any way by my dog(s). I specifically, without limitation, agree to fully indemnify Strutting Mutts for any and all such liability, claims, suits, actions, losses, injury or damage.

I certify that I have read and understand the rules and regulations set forth herein and that I have read and understand this agreement. I agree to abide by the rules and regulations and accept all the terms, conditions and statements of this agreement and confirm the truthfulness of the contents of the Application form completed by me.

Terms & Conditions

Payment

- 1. Strutting Mutts accepts cash/bank transfer, (please ask for bank details)
- 2. A 25% non-refundable deposit of the total sum due is payable to Strutting Mutts at the time of booking (For dog sitting/cat visits)
- 3. The remaining balance is due on or before the first date of service start date.
- 4. Where services are required long term, the client may make payment on a monthly basis.
- 5. Where payment is not received in accordance with these terms and conditions of business, the company reserves the right not to proceed with any previously agreed arrangements, and a cancellation fee will be payable.

Cancellations

- 1. All bookings cancelled within 24 hours will be payable in full.
- If Strutting Mutts cannot provide the service agreed, we will do our best to arrange an alternative, unless in extreme circumstances, where we will endeavour to give 24 hours notice.

Aggressive Animals

- 1. Strutting Mutts will not accept to look after aggressive animals.
- 2. The client agrees to be responsible for all costs (including but not limited to medical care, legal fees, etc) if the client's pet(s) should bite another animal.
- 3. Client agrees that on booking services for their dog(s) that they have represented that the dog(s) to have not shown aggression or caused harm, or threatening behaviour to any individual and/or any pet(s), and the client agrees to contact the provider as soon as possible if any of these behavioural changes presents itself or if it has the potential to cause harm to any individual or pet(s).
- 4. We will not walk unruly or untrained dogs.
- 5. If the client's dog(s) whilst being walked shows aggressive tendencies towards Strutting Mutts, or should its behaviour become unacceptable or a nuisance beyond reasonable acceptance, the client agrees that the service is terminated with immediate effect and the pet is to be returned to the location where it was collected.
